



Charlotte Jewish Community,

FCJC's success in 2018 was a direct result of our expertise and ability to assist our community donors. FCJC received gifts in excess of \$12.6 million with more than 75% of these assets earmarked for one of 20 new donor advised funds. Our donors established 24 new funds in 2018, increasing our total number of funds to 192. Throughout the year, we



continued to demonstrate our ability to leverage the resources of FFTC and assist our donors with gifts of nontraditional assets.

At year-end, total FCJC assets under management were \$136.2 million, a 3.9% reduction from the previous year. For only the fourth time in its 21-year existence, and first time in ten years, FCJC assets were less than the previous year-end. Our asset reduction was due to volatile fourth ouarter investment returns and a

record \$9.1 million of grant distributions to 300 approved charities. During the year, 820 grants were processed, a 39% increase from the previous year. This increase in grant activity is directly related to the growing number of community donors who have entrusted FCJC to assist them with their annual charitable giving and legacy planning.

Special thanks to our current fund holders and legacy donors. We encourage you to learn more about FCJC and our ability to assist you with your philanthropic planning.

FCJC's Create Your Jewish Legacy

FCJC's Create Your Jewish Legacy is a collaborative effort with our Jewish communal partners designed to build endowments through legacy giving. We began our efforts in 2012 with a focus on donor stewardship and recognition. The program is structured to assist our community donors with identifying their philanthropic interests and determining how to align those interests with the future needs of Charlotte's Jewish community.

In 2018, our efforts resulted in 21 new legacy donors bringing our total to 387. Since the program's inception, and in collaboration with our 10 community partner organizations, over 854 unique legacy gifts have been established.

Our legacy effort has received national attention and financial assistance from the Harold Grinspoon Foundation's Life & Legacy program, Jewish Federations of North America (JFNA) and local community donors.
