Letter to our Community

On the page opposite this letter is “Our Purpose.” This is meant to not only be a promise to you, our fundholders and community, but also to ourselves – a daily reminder of why we at Foundation For The Carolinas do what we do.

“Our Purpose” comes from the Foundation’s 2025-2030 Strategic Framework, which we launched last year. This organizational blueprint is meant to guide us as a Foundation through the next five years. At its core – and at the core of FFTC – is creating remarkable impact, a simple concept that is extraordinarily complex to achieve.

For starters, no one can create remarkable impact alone. You need partners. At Foundation For The Carolinas, our partners come in many ways – fellow nonprofits; community, civic, business and political leaders; regional voices; and, importantly, our fundholders.

We could not do what we do without you doing what you do ... and in 2024, boy, did you do it!

Our fundholders had a record year in grantmaking, granting nearly \$1 billion from their funds to nonprofits and worthy causes. That’s up 54% from grantmaking in 2023. Fundholders also contributed more than \$750 million to their funds – our second-highest total ever.

Think of the “remarkable impact” our 3,000 fundholders made last year. From our nonprofit clients, whose daily work benefits lives throughout our region, to the many causes supported by our corporate and family fundholders – from funding food pantries and scholarships to supporting local arts and so much more – thanks to you we see remarkable impact every day. It’s one of the main reasons we launched our FFTC Connects series for fundholders last year – to connect donors to issues and nonprofits they might not know about.

Let’s take remarkable impact further: When writing our Strategic Framework, we thought it important to detail our philosophy as an organization. Among the “north stars” to guide us are:


- We believe in the power of collective giving and open philanthropy.

We can get there with the help of all of you. As the year unfolds, think about how you can make your own remarkable impact – put it at the core of all you do, as well.


With that as our focus, we can achieve great things!

2024 Grants to Nonprofits

FFTC distributes grants to public charities within our 13-county region and throughout the United States.

The vast majority of grants (97%) are recommended by fundholders from their FFTC-held funds to benefit the nonprofits and causes of their choosing. Conversely, discretionary grants are recommended by FFTC's local volunteer boards and committees and represent 3% of total grantmaking.

The following charts represent total grantmaking from all FFTC funds, as well as the portion that is discretionary for the benefit of local needs:

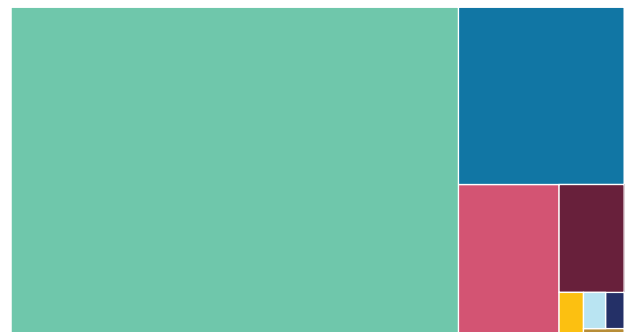
TOTAL GRANTS BY COMMUNITY IMPACT AREA INCLUDING FUNDHOLDER GRANTS

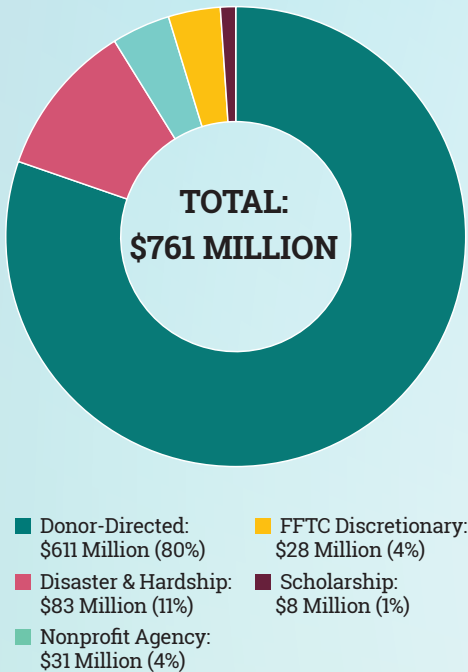

FFTC Funds: 2024 by the Numbers

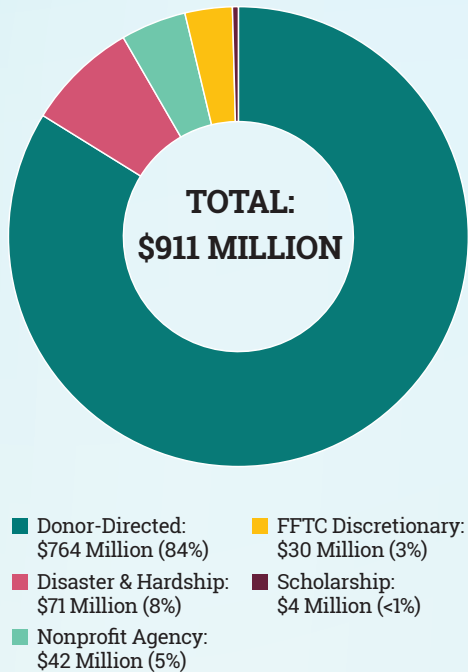
FFTC manages a variety of charitable fund types with different purposes and restrictions.

- **Donor-Directed:** Funds from which donors recommend grants to nonprofits most meaningful to them.
- **Nonprofit/Agency Funds:** Established by nonprofits for the long-term sustainability of their work.
- **Employee Disaster and Hardship Funds:** Managed by FFTC’s subsidiary, E4E Relief.
- **Discretionary Funds:** Allow FFTC’s volunteer grantmaking boards to address critical community needs.
- **Scholarship Funds:** Established by fundholders to help students achieve educational dreams.

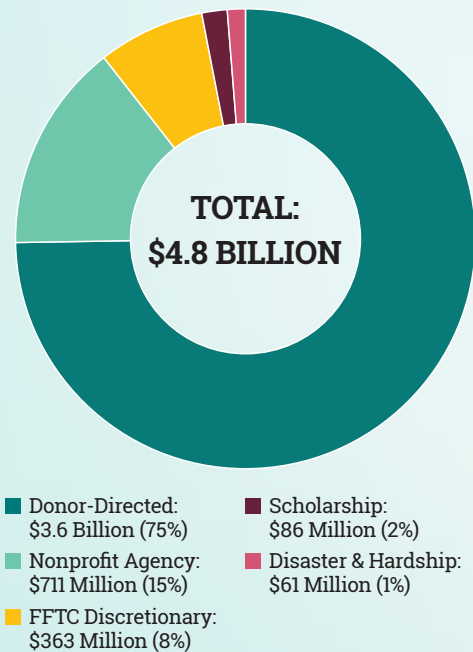
2024 CONTRIBUTIONS TO FFTC FUNDS BY TYPE

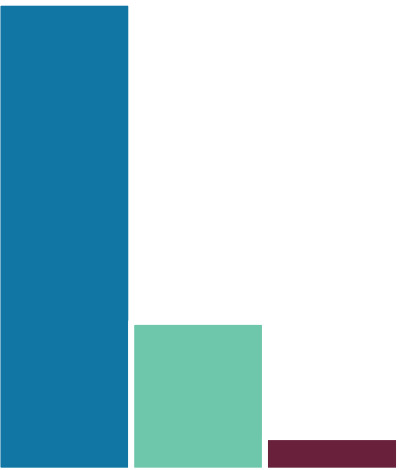
2024 GRANTS FROM FUNDS BY CENTER

Foundation For Black Philanthropy Celebrates 30 Years of Philanthropy

A testament to the power of collective impact, Foundation For Black Philanthropy – an affiliate of FFTC – celebrated its 30th anniversary in August 2024.

Honoring the long tradition of Black giving, FFBP is a collective grantmaking fund dedicated to empowering individuals, emboldening community and strengthening nonprofit organizations. Since its inception in 1993, Foundation for Black Philanthropy's board has granted more than \$600,000 to local nonprofits.

Its origins are thanks to the impact of two trailblazing women – Elizabeth S. Randolph and Lethia Henderson – whose individual endowments originally helped seed FFBP. To honor their generosity, last year, bronze plaques of the two philanthropists were added to Foundation For The Carolinas' Legacy Hall.



Lethia's Legacy

Entrepreneur, business owner, real estate pioneer, philanthropist – Lethia Jones Henderson may have been the best-known woman in Charlotte during the early part of the 20th century. Since her death, her impact has grown even larger.

Your Community Foundation in Action

At the Foundation, civic leadership is at the heart of our mission. Whether through the Robinson Center for Civic Leadership or our family of initiatives and affiliated organizations, we unite generous donors, community partners and local leaders to tackle the region's most-pressing challenges. We believe that by fostering collaboration and innovation, we collectively achieve lasting impact. Let's take a look back at some of the achievements of our initiatives and affiliates in the past year:

The Arts & Science Council

The Arts & Science Council drives cultural vitality, educational excellence and economic strength through strategic investments in arts and culture. In 2024, ASC joined the Foundation as a supporting organization, and also:

- Managed and stewarded 32 public art projects enhancing community spaces.
- Reached more than 66,000 students through diverse educational programs, fostering creativity and cultural appreciation.
- Helped secure \$1.4 million to support ASC's grantmaking, as well as spearheading \$3.2 million in investment for local creatives.

Owned and operated by Le and Minh Nguyen, Le's Sandwiches and Café is Charlotte's first authentic Bahn Mi restaurant. With a grant from Beyond Open, they were able to purchase new equipment to help streamline production and increase revenue.

Beyond Open

Beyond Open directly invests in the prosperity of local small businesses, reinforcing economic strength and sustainability across our community. Last year, the grantmaking program:

- Awarded \$5.8 million to 109 local small businesses in its third funding round, totaling \$16.3 million to 402 businesses over three rounds.
- Provided ongoing resource connections and practical support to all participating entrepreneurs and business owners.



Last year, Read Charlotte expanded the Queen City Readers tutoring program to assist early literacy efforts.

Read Charlotte

Through targeted campaigns and innovative programming, Read Charlotte equips our community with essential tools for literacy, empowering children to succeed academically and beyond. In 2024, the initiative:

- Launched the “Read Together” campaign, garnering 18 million social media impressions and engaging nearly 100,000 website visitors, emphasizing family-shared reading.
- Expanded the Queen City Readers tutoring program with participation from six community organizations and Pineville Elementary, enhancing early literacy with accessible, evidence-based methods.
- Implemented the Community Read-Aloud Model across six community groups, strengthening vital listening comprehension skills through engaging shared reading experiences.
- Piloted “Amira,” an AI-powered digital reading tutor, helping approximately 1,000 local students with both English and Spanish literacy development.

Leading on Opportunity

Leading on Opportunity mobilizes resources and action to significantly improve economic mobility and equity across Charlotte-Mecklenburg. Last year, the initiative:

- Surpassed fundraising goals by \$450,000, ensuring sustainable operations and community impact.
- Hosted Dr. Raj Chetty and the Opportunity Insights team for events around the publication of “Changing Opportunity: Sociological Mechanisms Underlying Growing Class Gaps and Shrinking Race Gaps in Economic Mobility,” which shows Charlotte moved from No. 50 to 38 in economic mobility.
- Finalized and adopted the 2024-2027 Strategic Plan, outlining clear objectives to advance economic mobility.
